Session

Board President Michael Goldberg welcomed those present and announced that the Board of Education was interested in encouraging all members of the public to share their ideas, comments and questions. He noted that public participation opportunities would be available at the beginning of the meeting and again at the end of the meeting and, as stated in Board Policy, no person should speak for more than three minutes and each period of public participation would be limited to thirty minutes. If there were questions or concerns regarding matters on the Consent Agenda, it would be important to utilize the first public participation opportunity as the Board would act on those items immediately. Mr. Goldberg pointed out the emergency exit. The public session began with the Pledge of Allegiance.

Superintendent's Update

PTA Board Recognition

Superintendent of Schools Paul Defendini introduced to the Board of Education Farmingdale Council of PTAs 2019-2020 President Colleen Giordano. Ms. Giordano presented gifts to the Board trustees in recognition of their unwavering support and efforts for the educational programs for the children of Farmingdale Schools. She stated that the individual building unit presidents joined her in thanking the Board and administration for the work that they are doing to enhance opportunities for all students. Board members also thanked the PTA for the strong partnership that, together, creates and encourages all Dalers.

Capital Projects and the – Thoughtexchange

Superintendent of Schools Paul Defendini provided an update to the Board of Education on the planned thoughtexchange effort, which will be used to obtain community input on the next phase of capital projects for the Board's consideration. Mr Defendini thanked the administration, pupil personnel staff, teachers, students and families who all responded to a recent tragedy.

School Athletic Complex ribbon cutting ceremony and anticipated homecoming rally.

Approval of the Tax Levy for the 2019/20 School Year RESOLVED, that the Farmingdale Union Free School District Board of Education approve a resolution that will set the total tax levy for the Farmingdale Union Free School District, Nassau County and Town of Babylon, for the 2019-2020 school year.

Discussion

Assistant to the Superintendent for Business Michael Motisi provided an overview of the 2019-2020 tax levy calculation. He began his presentation with a summary of the approved budget, which included a 2.73% tax levy increase. Factors included in this calculation are state and county determined assessed values, base proportions and equalization rates. He described Nassau County's four property classes and the changes in base proportions, the differences between calculations used in Nassau County and in the Town of Babylon and the equalization rates that determine the tax apportionment.

Mr. Motisi reviewed updated tax information, including legislation that made permanent the property tax cap, the sunsetting of the incentive check reimbursements to residents, the upcoming changes associated with Nassau County's effort to address inequities in the taxation systems and changes to the Basic and Enhanced STAR refunds.
